2. **3 picnic tables will be provided for party in grass area next pool . The party lasts for rental period only. The party must clear pool and grass area when rental is over.**
3. **Pool Rental does not include use of Cunningham Pavilion . If additional time is required, The Fred Ray Pavilion at the end of the park is available for rental at a additional cost.**
4. Applicant assumes responsibility of participants, spectators, and any damages.
5. Applicant and participants will abide by Hanlon Pool Safety Rules & Regulations provided with this form.
6. Compliance with all applicable laws & regulations of the State of New York, The Village of East Syracuse, and Onondaga County Health Department is a requirement of permit holder.
7. Certificate of insurance may be required. (We will inform you of this.)
8. The person listed on this form (and signing below as representing the above named group) is legally responsible for any and all actions of group members while they are in a Village of East Syracuse facility. This person will be held financially responsible and liable for any damage to pool property caused by a member of their group.
9. Designated pool toys will be provided & swim equipment may be brought from home & approved by guards.

Refund/Cancellation Policies-

1. If for some reason the pool is closed for your rental (inclement weather, chemical imbalance, etc.) you will have a full refund or rescheduling privilege for the cancellation.
2. If a rental takes place and the pool needs to be closed (inclement weather, chemical imbalance, etc) within the first HALF HOUR of your rental time, you will be granted the privilege to reschedule the remaining time of your rental.
3. If a rental takes place and the pool needs to be closed (inclement weather, chemical imbalance, etc) after the first HALF HOUR of your rental time, you will not be given a refund or rescheduling privilege but will have the option to wait out the break interval and return to the pool IF THE RETURN TIME falls within your scheduled rental time. (Upon the last sound of thunder, a 20 min. interim will restart. A chemical treatment is 30 minutes after dispensing shock.)
